

**ORDINANCE NO. G-10-04**

**AN ORDINANCE AMENDING CHAPTER 12 (FIRE PREVENTION AND PROTECTION), ARTICLE II (FIRE DEPARTMENT), DIVISION 3 (FIRE-FIGHTING SERVICE OUTSIDE CITY LIMITS), SECTIONS 12-44 (AUTHORIZED) AND 12-47 (PARTIES TO CONTRACT) OF THE CODE OF ORDINANCES OF THE CITY OF COFFEYVILLE, KANSAS.**

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COFFEYVILLE, KANSAS:

Section 1. That Chapter 12, Article II, Division 3, Sections 12-44 of the Code of Ordinances of the City of Coffeyville, Kansas, be and is hereby amended to read as follows:

**Sec. 12-44. Authorized.**

For and in consideration of the annual sum of \$200 for residential contracts and \$350 for commercial contracts, the City will, in accordance with and subject to the provisions of K.S.A. 80-1502, furnish fire fighting service to contracting parties whose property is located in Montgomery County, but outside the corporate limits of the City, and (a) within a distance of five (5) miles from the fire station located at Seventh and Walnut Streets or (b) located within the City's industrial park; provided, however, the five-mile distance provision shall not apply to parties under contract on the date of passage of this section. Additionally, the following fees shall apply each time fire apparatus leaves the city limits in response to a call from or on behalf of a contracting party, whether or not said apparatus is actually used upon or for the protection of the property:

Up to one (1) hour	\$400	\$500
Each hour thereafter	\$300	\$500
Maximum charge	\$1300	N/A

Section 2. That Chapter 12, Article II, Division 3, Sections 12-47 of the Code of Ordinances of the City of Coffeyville, Kansas, be and is hereby amended to read as follows:

**Sec. 12-47. Parties to contract.**

Names of persons or businesses who have executed fire-fighting contracts with the City pursuant to Section 12-44, together with a description of the property, and a map depicting the location of said property for which service is to be rendered, shall be listed in a schedule on file in the office of the City Clerk. All of the provisions of this Division shall be binding upon each of the parties to the contracts, including payment of the fees set forth in Section 12-44. In addition, each contracting party shall be required to provide a Certificate of Insurance including a minimum of \$1,000 (residential) or \$5,000 (commercial) for fire-fighting coverage (Code 1965, § 8-301; Ord. No. G-79-04, § 1, 8-8-79; Ord. No. G-90-08, 6-25-90).

Section 3. This Ordinance shall be effective upon publication in the official city newspaper.
