### **PURPOSE**

USDA is committed to providing access for safe, decent and affordable housing for rural Kansans. The City of Coffeyville intends to collaborate with USDA Rural Development of Kansas and provide Coffeyville with the Mutual Self-Help Program. The Mutual Self-Help Program provides grant funding to advance homeownership in Coffeyville through the implementation of local self-help housing construction projects. The Program supports the City of Coffeyville in carrying out projects, assisting groups of individuals and families with low-incomes as they construct their own homes. The Program helps people, who do not qualify as homeowners, obtain affordable, clean, and safe homes of their own, with priority for loan assistance given to families living in substandard housing.

The Mutual Self-Help Program has many other benefits to Coffeyville, such as stimulating the local economy, providing job training and instilling a deep sense of community. The Program also provides families with affordable home ownership with minimal out-of-pocket expense; teaches construction skills; instills pride and a sense of ownership; and families work together for a common goal to build strong communities.

With the assistance from the USDA Rural Development Self-Help Housing Program, the City of Coffeyville will coordinate the Program by finding building lots, developing house plans, working with contractors, coordinating materials, training participants on construction skills and supervising construction. #### **BACKGROUND**

Increasing economic opportunity and improving the quality of life for people in rural America is the goal of the U.S. Department of Agriculture's (USDA) Rural Development mission area.
