1. Discussion to reconsider the submittal of a geometric application to KDOT for the intersection of West Highway 166/Eighth Street.
  - Mayor Falkner stated he had received negative comments regarding the proposed project mainly related to the cul-de-sac. He also felt it was an awkward transition to the highway.

  - City Manager Bradley provided drawings on a proposed alternate, which had also been presented to Commissioners on May 8, for Sunflower and Northeast along with a drawing of a roundabout design for the West Highway 166 and 8<sup>th</sup> Street project. Commissioners were not in favor of a roundabout for Coffeyville. Edwards stated the City does not have to apply for KDOT projects and could use the matching dollars required for residential streets. Commissioners requested future project submittals be fully vetted prior to bringing them for approval.
