Site Plan: Indicate the Property Line, Property Size (to scale or dimensions shown), North Arrow, Adjacent Street(s), Location of Building, Proposed Sign construction location, Sign location dimensions from Property Lines,

Elevation Drawings: Illustrate the Sign front, sides and rear views (for two faced), with dimensions and anchoring. Indicate materials to be used.

Electrical Plan: Indicate the location and size of new electrical service and describe new panelboard location. Indicate lighting type, arrangement and location of any electrical receptacles.

Structural Plan: Indicate the footing, foundation, roof framing, column and load bearing systems for signs, as applicable for sign type, noting sizes and strengths of materials used. Note design criteria, including loads.

Construction Details: Illustrate the construction materials and methods as necessary to convey to the Building Official, compliance with applicable provisions of the current codes and standards.
